

re: CIVIL CASE HBC 158 OF 2000L AND 100 OF 2003

Sir,

Greetings from Prison to my Naita and congratulations for getting your job back. Keeping track with the Media, I have been aware that you have dismissed five(5) senior Officers and are calling for the removal of others for the sake of National Security.

The principle of "Doing to others what you would like to be done to you," I noticed is not practised because as soon as you secure your job, you called for others to be removed from theirs? These are fellow Fijians who have families and I am reminded of the occassions where you had declared that you were more Nationalistic than I was.

This was true when I regarded it then in my meeting at your Office on June 01, 2000. Along with you at the Officers Board Room were Colonel Tuatoko, Lt Col Raduva, Lt Colonel Lesi Korovavala, Lt Colonel Tarakinikini and others. Before we began that meeting you revealed that we had met before the Coup and you had asked me to hand over the weapons, for the C.R.W to return, the hostages released and to let you run the show. You had denounced me saying that I had no credibility. I merely wished that we resolve the Displacement of Mahend as you wanted because your proposal was alright. We agreed that I must inform Goerge Speight of your conditions and the Vanna who were with him in Parliment. We later met at the Officers Mess at 2am and you agreed to see them at 1000 am the same day.

While I had lunch at the Officers Mess your talks pesulted in the drafting of the QEB Accord, later delays culminated in the Muanikau Accord. After 56 days of negotiations with George, I knew that you were not going to honour your Accord with him. He appeared at an oppotunistic time claiming all the credit from the removal of Mahends Government of which I was part. Your own Soldiers were the sacrificial lambs. In the meantime, you are credited with the restoration of law and order and no one's the wiser.

I had refused to be part of the Interim Government as Assistant Minister for Mealth, not because I did not want to serve under Qarase but rather to avoid conflict of intrest with you because you do not have the confidence in me.

When I was earmarked to be arrested, I was not suprised and after drinking grog at the Officers Mess, I was dropped off home in Lt Col Scruvakula's 4 wheel drive. In the morning at 4am I was called to get ready and was picked up, taken to Camp tied up and taken to the HMS Kiro bound for Nukulau. Later you turned up and had BEQ with us. You assured us or rather you were talking to me about a Court Case and release. But the release were only for some others and not all after Nov 2nd, 2000. I'am serving my time and we are both liable for Civil Litigation by certain people. The last time I appeared in Court, you had a motion to quash the writ. I know that your strategy is to extract your liability from the event of 2000.

Je information of prisoner's families and friends. The privilege to write and receive letters is given to prisoners for the purpose of enabling them to keep in touch with their relatives and friends. All letters are read by the Prison Authorities. They must be legibly written. Any which is of an objectionable nature either to or from a prisoner will be suppressed. Every prisoner shall be allowed the privilege of writing one letter on admission and thereafter as follows-

Prisoners in the First and Second Stages	l	- one letter every fortunation
Prisoners in the Third Stage	1	one letter every 10 days
Prisoners in the Special Stage	1	one letter in every week
Carlo Daniel Carlo	.!	one letter in every week
Transpired Criminal Prisoners	.1	write whenever they desir

Matters of special importance to the prisoners may be communicated at any time by letter to the Officer-in-Charge who will inform the prisoners thereof if expedient

Persons attempting to communicate with prisoners contrary to the rules or to introduce any article to or from prisoners are liable to a fine or imprisonment or to both and any prisoner concerned in such practices is liable to be severely punished.

Prisoners friends and relatives are sometimes approached by unauthorised persons to send money etc. to them privately under pretence that they can apply for it for the benefit of the prisoners and under such fraudulent pretence such persons endeavour to obtain money for themselves. Any letter containing such applications should be forwarded at once to the Supervisor or Officer-in-Charge.

Prisoners may be permitted to receive visits as follows-
