Commander accused of bidding for Head of Government post

CONTROVERSIAL military man Filipo Lieutenant-Colonel Tarakinikini says Army Commander, Commodore Frank Bainimarama wanted to remain Army Head of State after the political crisis

In his latest letter to Commodore Bainimarama, Lt-Col Tarakinikini claims that "I was the one who told you to immediately relinquish the executive authority of Head of State executive authority of Head of State that you insisted on holding onto, back to where it rightly belongs - in the Bose Levu Vakaturaga".

"As I tried to tell you this was necessary in order to help break the deadlock in negotiations to secure the release of hostages."

Lt-Col Tarakinikini wrote to Commodore Bainimarama after the military instructed him to return to

military instructed him to return to from New York or be charged with desertion

The career military officer was

told he faced extradition if he did not

return. Lt-Col Tarakinikini has been Lt-Col Tarakinikini has been ordered home to answer to allegations that he was involved in the overthrow of the Mahendra Chaudhry led People's Coalition Government in 2000 and was instrumental in instigating the November military mutiny the same year

Lt-Col Tarakinikini challenged Commodore Baunimarama to come out publicly to state allegations against him and to state allegations against infill and provide the supporting concrete evidence and not hearsay and rumours that I have been investigated on in the past.

"I hereby formally request a copy

of the board of inquiry report by Lt-Col Jackson Evans that you use as the foundation of baseless allegations against me," he said. Lt-Col Tarakinikini warned the

Commander that if he did not receive the report his lawyers would obtain it

The former May 2000 failed coup military spokesman said with all respect, the Commander's response to his resignation aims to cast doubt on him and "is evasive and manipulative in avoiding issues".

"It says nothing of substance and is silent on issues I raised as some of is such with issues a some of the reasons prompting my resignation. Section 194 (2) b of the Constitution provides me the absolute right to resign from the force. I exercised this right in my letter of resignation dated February 27

27.
"My resignation was formally you. Ny resignation was formally accepted once received by you. Therefore, it is effective no later that March 18 2002 as that is the date of your reply," he said.

Lt-Col Tarakinikini said some

need to understand military command properly as in military command properly as in military law, command responsibility is total and one cannot continue to pass the "buck of command failure" to those soldiers and officers under command.

Lt-Col Tarakinikini said the recent record for power abuse, human rights abuse and command failure will forever remain in Fiji darkest memories.

"The CRW was under direct the CRW was under three command of someone and not me ... the fact that outsiders used them is only an example of the failure of command. This and other serious failures remain uncorrected.

failures remain uncorrected.

"No amount of denial and cover up investigations will absolve responsibility for that failure from where it truly belongs and all professional officers and soldiers know this," he said.

Lt-Col Tarakinikini said a proper Public Commission of Inquiry will bring out these facts and identify who are the ones that have really failed the nation.

"If this scenario occurred in other deprocratic state under similar set of

democratic state under similar set of laws and constitution, resignations would have handed in long ago if not demanded to make way for proper

derinanced to make way for proper public commission of inquiry to be convened," he said.

The military yesterday refused to comment saying the matter was an internal one.

Chaudhry's \$49,000 in court costs

THE Fiji Labour Party is seeking \$49,000 in court costs from the Fiji Government to cover costs for their counsels and displacements and have sought clarifications on the formation of a multiparty concept.

And the case was deferred yesterday because the State could not provide hard copies of affidavits submitted for the case. The deputy Solicitor-General, William Culachini, who represented the State said the affidavits in their possession were faxed soples and did not have "as yet the original papers of the affidavits that were needed".

copies of the affidavits that were needed". Labour lawyer Ganga Shankar sought clarifications from the courts in respect to the High Court decision last month on how the multi-party government should be formed.

A High Court decision last month directed that the Fiji Labour Party is entitled

to be part of Government. However, Government had decided it would be appealing the decision. Lautoka High Court Judge, Justice Anthony Gates yesterday said he was awaiting the affidavits from the State counsel before a decision is reached on any payments and any other agreements.

Of the sum Labour is seeking, \$AU20,000 to cover the Australian counsel costs, \$10,000 for instructing solicitors and \$19,000 for displacements.

Mr Calachini yesterday questioned the appropriateness of moving the court hearings from Suva to Lautoka.

While calling for justification of awarding costs, he however agreed that indemnity costs should be allowed.

Mr Calachini said that though the

Mr Calacinin said that though the affidavits had been received by fax, "its hard copy had not found its way".

Justice Gates requested for a second swom affidavit to be served on April 23.

He commented that constitutional cases of this sort "tend to gather emotions as with the Chandrika Prasad case so they had to be

attended to carefully".

It is understood the two parties had reached some agreements but these were not disclosed.

The case has been adjourned to April 24 at the High Court in Lautoka.
